### Chapter 2.7

#### AGED AND DISABLED PROGRAM

**2.7.1. Authority.** This ordinance hereby establishes a program to provide financial assistance to the aged and disabled and is adopted pursuant to the authority vested in the Suquamish Tribal Council by virtue of its inherent sovereignty as an Indian tribal government and Article III of the Constitution and Bylaws of the Suquamish Tribe that provides that the governing body has the power to pass ordinances that govern the conduct of all persons and regulate all property within the Tribe's jurisdiction to the fullest extent allowed under applicable federal law, that provide for the maintenance of law and order and the administration of justice, and that promote the social and economic welfare of the Suquamish people. **2.7.2. Purpose.** The program established under this section is a needs-based program that satisfies the criteria of Section 505(b) of Public Law 94-566 in which eligibility is determined based on the applicant's eligibility for other assistance programs in which income or resources are used as eligibility criteria. (Res. 2010-200, passed Nov. 1, 2010)

**2.7.3. Definitions.** For the purposes of this chapter, the words and phrases listed below have the following meanings:

(a) "Supplemental Security Income" or "SSI" means a cash assistance program funded by general tax revenues and administered by the federal government under Title XVI of the Social Security Act that is designed to help aged, blind, and disabled people, who have little or no income and to provide cash to meet basic needs for food, clothing, and shelter.

(b) "Suquamish tribal member" means a person duly enrolled with the Suquamish Tribe in accordance with the Constitution and Bylaws of the Suquamish Tribe and the Suquamish Tribal Code.

(c) "Suquamish tribal elder" means a Suquamish tribal member who is fifty-five (55) years of age or older. (Res. 2010-200, passed Nov. 1, 2010)

**2.7.4. Eligibility for Financial Assistance.** (a) To be eligible for assistance under this chapter, an individual must be a Suquamish tribal elder or a disabled Suquamish tribal member and must declare under the penalty of perjury on a form approved by the Tribal Council that he or she is eligible for Supplemental Security Income (“SSI”), Medicare, Medicaid, or other state or federal assistance programs on the basis of income or resources.

(b) A person receiving aid under this program may not receive monetary benefits distributed by the Suquamish tribal government to individual Suquamish tribal members arising from treaty resources or other tribal monetary benefit programs. Only one program may be used at a time by a Suquamish tribal member. In order to qualify for aid under this section, the recipient must first sign a waiver in a form satisfactory to the Tribal Council disclaiming any right to monetary benefits arising from treaty resources distributed by the tribal government to individual Suquamish tribal members. **2.7.5. Distribution of Funds to Eligible Participants.** On an annual basis, the Tribal Council shall authorize the distribution of funds to eligible participants in the program by determining an annual amount for each participant after consideration of available funding and the participant’s level of income and/or resources. Payments will be distributed to eligible participants in equal monthly amounts.(Res. 2010-200, passed Nov. 1, 2010)
