**COVID-19 Housing Relief Application**

The Suquamish Tribal Council is aware of the financial hardship and uncertainty our membership is facing during this COVID-19 pandemic. We have met to discuss ways in which we can help alleviate the financial stress our membership is currently facing. One way to relieve some financial stress is to assist our tribal tenants who are unsure how they will make their upcoming housing payments.

Tribal Council directs the Executive Director and DCD to develop a policy and program to allow tribal tenants to apply for a rent reduction or a rent deferral. This program should allow for a rent reduction or deferral from May until July. Tribal Council also directs DCD to not issue any eviction letters or assess any late fees during this crisis.

The COVID-19 Housing Relief Application is designed for tenants who reside in Suquamish Tribal Housings, Elder Housings, NAHASDA Housings, Suquamish Steps Program, and Mutual Help Homeownership programs affected by COVID-19 “Stay at Home” order. Residents may be eligible for a payment options for their housing payment from May 2020 through July 2020 due to financial hardship.

Options (Choose one)

- Housing payment Deferment (is not payment forgiveness, a payment plan will be created for repayment, please fill out Worksheet A & B)
- Housing payment reduction (may be eligible for a percentage reduction of housing payment, please fill out Worksheets A & B, also not a payment forgiveness, a plan will be created for repayment)
