If a position indicates “**FULL-TIME/CONTRACT**,” it refers to an Employment Contract position. If a position indicates “**CONTRACT**,” this signifies that it is solely an Independent Contract position. If a position indicates “**SEASONAL**,” this signifies that it is solely Temporary/Seasonal role, lasting for a duration of three months.
